## Other than Full and Open Competition

The preferred procurement method of obtaining goods, services or construction is by utilizing full and open competition.

The Airports Authority is committed to the maximum extent practicable to obtain full and open competition when acquiring goods, services, and construction.

However, there are circumstances when the Airports Authority may and will have to acquire goods, services and construction with other than full and open competition or under limited competition.

# Other than Full and Open Competition (Continued)

The Airports Authority Contracting Manual has identified categories in which Other than Full and Open competition may apply:

- 1. Urgent and Compelling The needs of the Airports Authority is of such an unusual and compelling urgency that the Airports Authority would be seriously injured financially or otherwise, unless the Airports Authority limits the number of sources from which it solicits bids or proposals (e.g., urgent safety and security considerations).
- 2. Airline Improvements to Airport Facility Approved airline facility improvements made by airline tenants that benefit the Airports Authority.
- 3. Sole Source The needs of the Airports Authority are available from only one responsible source and no other source will satisfy these needs.



### **Definition of Sole Source**

The Airports Authority Contracting Manual defines "sole source" as "There is only one responsible or one practicable source for required goods, services or construction, and no other supplies or services will satisfy the Airports Authority's requirements."



### **Sole Source Contracting**

Sole Source procurement is not unique and every public organization with procurement needs at some time engages in Sole Source contracting.

Sole Source procurements are noncompetitive negotiated procurements used to acquire goods, services and construction.



# Sole Source Contracting (Continued)

A forecast of **potential** sole source awards for the remainder of the year has been developed; Sole source acquisitions fall into four categories, and may include 18 awards including:

#### 1. Unique or Innovative Concepts.

Example: (Previously approved sole source) Engineered Material Arresting System (EMAS); the only crushable concrete system approved by the FAA to be used in the Runway Safety Areas.

#### 2. Patents or Restricted Data Rights.

Example: (This type occurs rarely) Nothing projected in next 12 months.



# Sole Source Contracting (Continued)

3. Proprietary Equipment and Software. May result in a long term partnership subsequent to full and open competition.

Example: (Potential future sole source) Maintenance and support for the Dulles Toll Road Toll Collection System.

Example: Software Maintenance and support for Dulles Airport Common Use airline terminal equipment.

Example: Ceridian software support services for human resource system.

#### 4. Utility Services and Supplies.

Example: (Potential future sole source) *Dominion Virginia Power* - Electrical power for Washington Dulles International Airport.



### **Sole Source Compliance**

The Airports Authority's guidelines for Sole source contracting:

- Require that potential sole source procurements exceeding \$50,000 to be posted on the Airports Authority website.
- Sole source procurements must be adequately supported by written justification, documenting the conditions which preclude the use of competition.
- Board approval must be obtained for the use of any Other Than Full and Open competition for all procurements above \$200,000.



# Sole Source Compliance (Continued)

- Notice of Intent to award a sole source contract exceeding \$50,000 must be posted on the Airports Authority's Website 15 days before award, allowing for any challenges to the award of a sole source contract.
- Information regarding award of the sole source contract will remain posted on the website for 30 days.

Section 2.9.3 of the Contracting Manual is explicit as the procedures and process that must be adhered to when using the sole source contracting method.

#### UTILIZATION OF OTHER THAN FULL AND OPEN COMPETITION

#### **MAY 2013**

#### **PURPOSE**

To advise the Committee on the Airports Authority need to use "other than full and open competition" and particularly the sole source contracting method for procurement of certain goods, services and construction. This paper provides information on potential sole source procurements and the process that will be used whenever they are necessary.

#### BACKGROUND

At its March 20, 2013, meeting, the Board of Directors approved the Fourth Edition of the Contracting Manual. Procurements to which the Manual applies now fall into two categories: those subject to "full and open competition," and those subject to "other than full and open competition." The latter category of procurements consists of three types of acquisitions: those addressing "urgent and compelling needs"; those involving "airline improvements to airport facilities", and those seeking goods or services available only from a "sole source."

#### **DISCUSSION**

There are circumstances when the Airports Authority may and will have to acquire goods, services and construction with other than full and open competition or under limited competition. The Airports Authority Contracting Manual has identified categories in which other than full and open competition may apply:

- 1. **Urgent and Compelling** The needs of the Airports Authority is of such an unusual and compelling urgency that the Airports Authority would be seriously injured financially or otherwise, unless the Airports Authority limits the number of sources from which it solicits bids or proposals (e.g., urgent safety and security considerations).

types of procurements are not unique and every public organization at some point needs to engage in sole source contracting.

The following are examples of bases for sole source acquisitions:

- Unique or Innovative Concepts The supplies or services to be acquired are unique to a contractor and no other source meets the needs of the Airports Authority.
- Patents or Restricted Data Rights Intellectual property or proprietary rights that preclude competition.
- Proprietary Equipment and Software Acquisition of proprietary equipment or software if required to be compatible with and is an integral component of an existing system to continue without disruptions to the operation of the Airports Authority.
- **Utility Services and Supplies** Utility services or supplies are available from one actual, or practicable source (e.g. water, electricity, etc.).

The Airports Authority is committed to full transparency whenever the need for sole source contracting occurs. Potential sole source procurements exceeding \$50,000 will be posted on the Airports Authority website for 15 days prior to award and remain posted for 30 days. All sole source procurements will be adequately supported by written justification, documenting the conditions which preclude the use of competition and sole source procurements exceeding \$200,000 will be presented to the Committee and Board for approval.

#### **CONCLUSION**

The report is for informational purposes to familiarize the Committee with the potential for using sole source procurement method for certain goods, services and construction.
