


Dulles Corridor Metrorail Project

At-a-Glance

- Seamless integration with current 106-mile Metro system
- 23-mile extension that branches off existing Orange Line after East Falls Church Station, providing direct connections to DC without transfers
- 11 new stations
 - 5 in Phase 1
 - 6 in Phase 2
- Phase 1: East Falls Church to Wiehle Avenue in Reston; opens in 2013
- Phase 2: Wiehle Avenue through Dulles Airport to Ashburn; complete in 2017, opening date not set




Route Map



DBE Overview


- Our FTA established DBE Goal on Phase 1 was \$109M. By April 2011 we had exceeded that goal and as of September 2012, DBEs have been paid approximately \$224M.
- The Goal on Phase 2 is expected to equal 25% of the Federal financial participation. Package A has already been advertised and includes a DBE Goal of 14% of the total contract value.

























Phase 2
