Metropolitan Washington Airports Authority Financial Statements February 2013 Aviation Enterprise Fund – Highlights in Brief

- ✤ Total operating revenues for the Aviation Enterprise Fund for February 2013 were \$56.5 million. Operating revenues decreased from January 2013 by \$3.4 million mostly due to decreases in concessions of \$1.6 million, landing fees of \$1.5 million and rents of \$0.3 million.
- Year-to-date operating revenues through February 2013 were \$116.3 million, which is an increase of \$6.6 million over 2012 totals. Increases in revenues are due primarily to higher rates, represented by increases in rent revenues of \$3.1 million, concessions of \$1.7 million, landing fees of \$1.4 million, passenger conveyance fees of \$0.2 million and utility sales of \$0.1 million.
- ✤ Total operating expenses for the Aviation Enterprise Fund during the month of February 2013 were \$49.2 million, which is \$2.3 million lower than for January 2013 mostly due to decreases in salaries and related benefits of \$2.1 million, utilities of \$0.8 million, services of \$0.5 million, insurance of \$0.2 million, telecommunications of \$0.1 million, offset by increases in depreciation and amortization of \$1.1 million, materials and supplies of \$0.2 million, and project expenses of \$0.1 million
- Year-to-date operating expenses through February 2013 were \$100.7 million, which is higher than 2012 by \$1.1 million primarily due to increases in salaries and related benefits of \$1.2 million, project expenses of \$0.5 million, telecommunications of \$0.2 million, offset by decreases in materials and supplies of \$0.3 million, utilities of \$0.3 million, insurance of \$0.1 million and services of \$0.1 million.
- ✤ Operating income for the Aviation Enterprise Fund in February 2013 was \$7.2 million compared to operating income of \$8.4 million in January 2013.
- → Year-to-date through February 2013, operating income was \$15.6 million compared to the operating income of \$10.2 million through February 2012.
- → Net non-operating expenses in February 2013 were \$19.9 million compared to net non-operating expenses in January 2013 of less than \$0.1 million. This is an increase in net non-operating expenses of about \$19.8 million primarily due to a \$21.0 million decrease in the change in the swaps fair value offset by increases in investment gains of \$0.8 million and a decrease in interest expense of \$0.4 million.

- → Through February 2013, year-to-date net non-operating expenses were \$19.9 million compared to net non-operating expenses of \$28.4 million in 2012. The positive difference of \$8.5 million is mostly comprised of a \$8.0 million positive difference in the change in the swaps fair value, a reduction in interest expense of \$1.0 million, offset by an unrealized investment loss of \$0.6 million.
- → The capital contributions for the Aviation Enterprise Fund for the month of February 2013 were \$11.0 million compared to \$5.4 million in January 2013. The \$5.6 million increase is mostly due to an increase of \$3.9 million in federal, state and local grants and an increase of \$1.6 million in passenger facility charges. Year-to-date capital contributions were almost \$16.4 million, up by \$0.2 million from 2012, due to an increase of \$ 0.9 million in grants offset by a decrease of \$0.7 million in passenger facility charges.
- → There is a decrease in net position for the Aviation Enterprise Fund for the month of February 2013 of \$1.6 million as compared to an increase in net position for the prior month of \$13.8 million.
- → The year-to-date increase in net position through February 2013 was \$12.2 million, compared to a year-to-date decrease in net position of \$1.9 million through February 2012.
- Accounts receivables delinquent over 30 days, including amounts past due which are in bankruptcy proceedings, had a balance of \$4.2 million as of February 28, 2013, an increase of 21% from January 31, 2013. Delinquent accounts receivables for customer accounts which have a net credit balance are excluded from reported delinquent receivables.
- → Debt service coverage decreased from 1.36x in January 2013 to1.33x in February 2013.

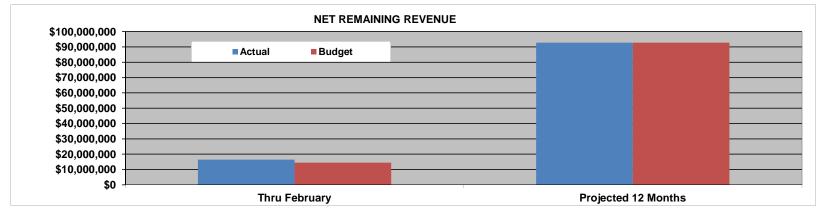

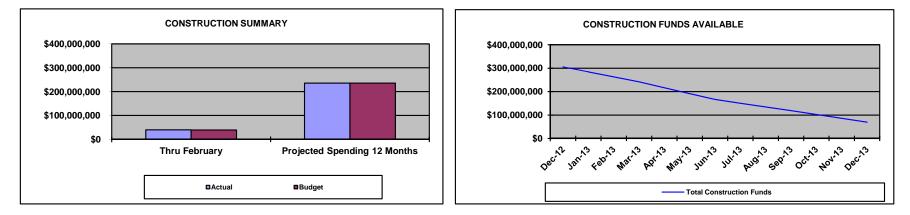

At the end of February, the estimated Net Remaining Revenue (NRR) is \$16,405,030. At 16.7% year-to-date, the Airports Authority has earned 17.7% of the budgeted NRR.

The year-to-date construction spending is at \$40.2 million. The 2013 budget for Capital Construction Program expenditures totals \$235.9 million.

Short-Term Liquidity Forecast: As of February 28, 2013 the Authority had \$263.2 million available in construction funds, which includes \$232.5 million on the shelf in Commercial Paper Series 1 fund. Of the funds on hand as of the end of February, \$75.0 million were PFC and Grant recycled funds. PFC and Grant recycled funds are available for the same purpose as AMT bond funds. Included in the funds on hand as of February 28 were \$800 thousand of non-AMT bond funds, the majority of which is from the 2010A debt issuance.

Metropolitan Washington Airports Authority Analysis of Delinquent Accounts Receivable As of February 28, 2013

Delinquent accounts receivables invoices over 30 days past due date for Ronald Reagan Washington National Airport as of February 28, 2013 total \$588,563. Delinquent accounts receivables increased by a net amount of \$230,643 (64.4%) during the month.
