If requested, Contractor shall furnish evidence of such insurance in form and substance satisfactory to the Authority.

To:

Contractor shall maintain adequate liability, employer's liability and workers' compensation insurance to protect the Authority and the Authority's agents, employees, and contractors with respect to the indemnity contained in Section VI.03 and any claims under workers' compensation, safety and health and similar laws and regulations relating to the goods or services furnished hereunder. If requested, Contractor shall furnish evidence of such insurance in form and substance satisfactory to the Authority.

- Section VI.04 Temporary Tags, is hereby changed:

30-Day Temporary Tags shall be furnished upon pickup of the Covert Tactical Armored SUV.

To:

30-Day Temporary Tags shall be furnished (if available through respective state Department of Motor Vehicles) upon pickup of the Covert Tactical Armored SUV.

Except as provided herein, all terms and conditions of the document referenced in Block 1A, as heretofore changed, remain unchanged and in full force and effect.
