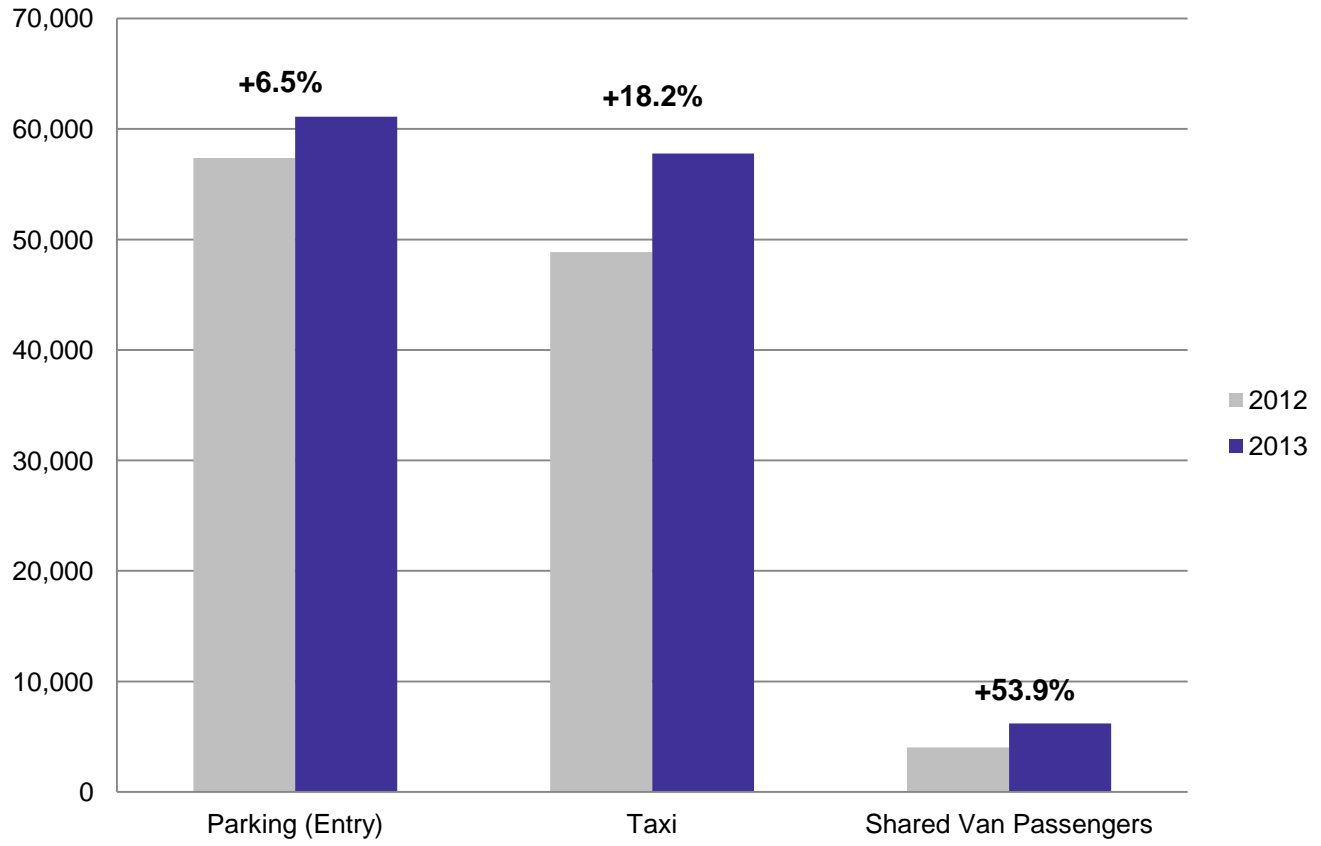
Reagan National Holiday activity from Dec 16, 2012 through Jan 1, 2013

- Great effort by our TSA and Airline partners
- Pax screened: +7% over 2011
- Ave AM wait time: 6.6 minutes
- Ave PM wait time: 4.10 minutes
- Max wait times: Center Pier 23 minutes. South Pier 25 minutes. Terminal A 25 minutes. North Pier 23 minutes.

- Economy Lot occupancy: 86.3 % (100% on Dec 24 and Dec 25)
- BC Daily occupancy: 68.9 %



Landside Passenger Traffic Comparison

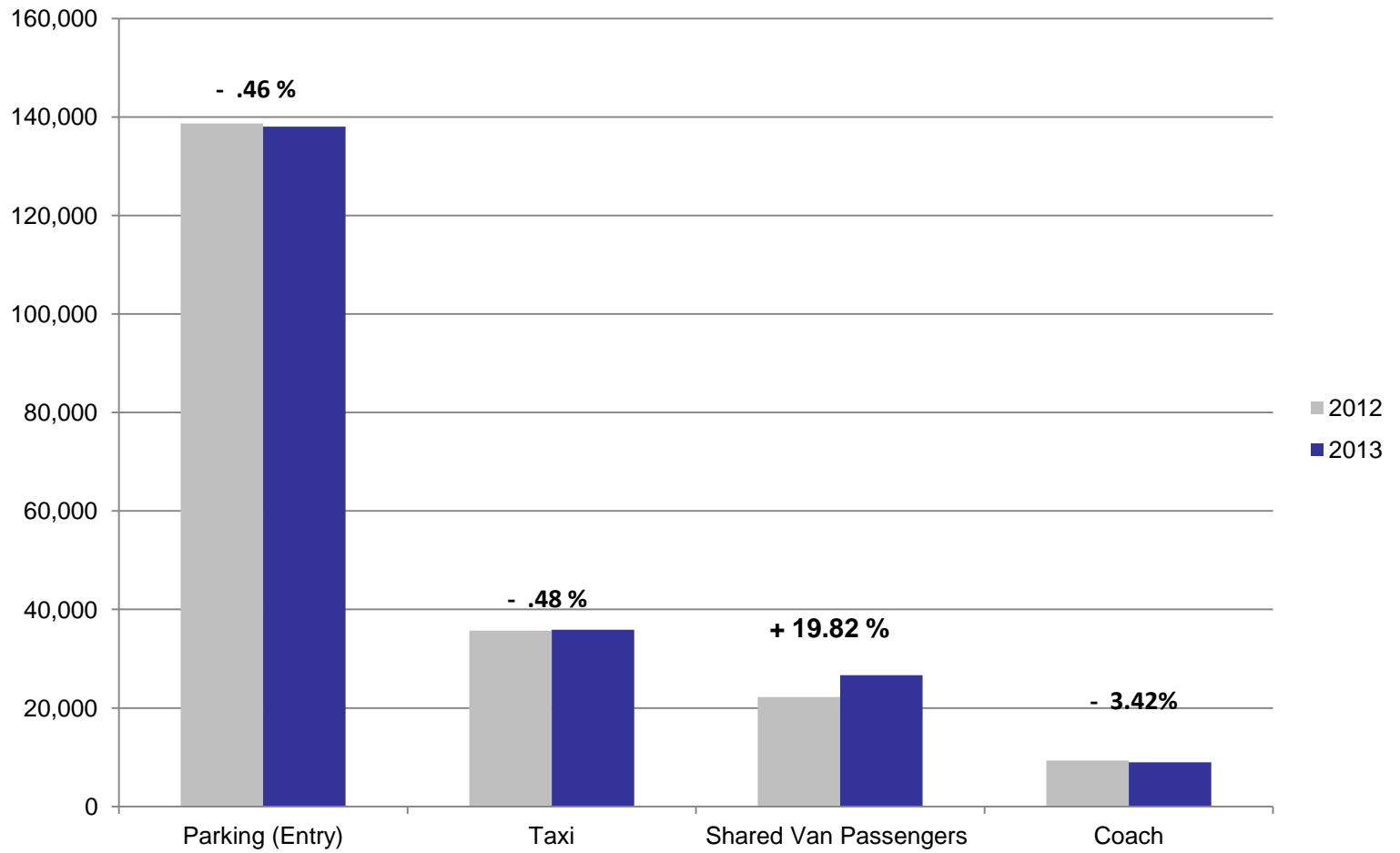


Dulles International Holiday activity from Dec 16, 2012 through Jan 1, 2013

- Ave AM wait time East Mezzanine: 5.6 minutes
West Mezzanine: 11.6 minutes

West Mezzanine: 7.9 minutes
- Max wait times: East Mezzanine: 20 minutes
West Mezzanine: 40 minutes

Presidential Inauguration

January 2013

Event Background

By law, the President must take the Oath of Office on Sunday, January 20, before noon. This first Oath of Office will take place at the White House.

The second Oath of Office will take place at the Capitol Building on Monday, January 21, at 11:30am.

Monday, January 21, is also the Martin Luther King, Jr. Holiday.

Expected crowd size is between 500,000 and 800,000 this year, down from 1.8 million in 2009.

All bridges and major roadways will be open with the exception of the Memorial Bridge.

Two Inaugural Balls will be held in the Washington Convention Center.

Public Safety Overview

Monday, January 21

- 10 Airports Authority police officers will support Metro Transit for 12 hours.
- The Fire and Rescue Department will be assisting DC Fire and EMS with a Utility Transport Vehicle, a Medic unit, and four personnel.
- An additional Medic personnel will be staffed at Reagan National.

- Airports Authority's Emergency Operation Center (EOC) will operate from 7 a.m. to 7 p.m.
 - Staffed by Police, Fire, Radio and TSA.
 - Focus on regional situational awareness and as a start-up EOC team should a critical incident occur.
- An Airports Authority police lieutenant will be stationed at the Multi-Agency Coordination Center (MACC) located in Maryland.

Public Safety Overview

Tuesday, January 22

The day after the Inauguration is expected to be our heaviest travel day. All officers will be in uniform and prepared to assist with Airport crowd control.

Ronald Reagan Washington National Airport

- Main focus will be passenger flow in the terminals.
- Staff, Student Ambassadors and Travelers Aid volunteers will focus on arriving passengers on Friday, January 18, and departing passengers on January 22.
- Staff volunteers and Student Ambassadors will be roaming the terminals in identifiable apparel.
- Staff is reaching out to DC Destination and local Chambers of Commerce to encourage hotel check-out times on Tuesday, January 22, be relaxed in an effort to stagger arrival of passengers at the Airport throughout the day.

Ronald Reagan Washington National Airport

- TSA will open screening checkpoints at 0400 on January 22 and increase staffing.
- Amenities, including bottled water, pillows and blankets, have been fully stocked to support delayed passengers.
- Signs and stanchions will be used to manage passenger queue lines and beginning and end of lines at the ticket counters for departing passengers.



Ronald Reagan Washington National Airport

- Wheelchairs will be available for passengers.
- Additional custodial staff will be on duty January 18 and January 22.
- Additional Taxi Dispatch management will be on duty January 18 through January 21.
- Additional parking staff will be on duty January 21.



Washington Dulles International Airport

Washington Dulles International Airport

- Main focus is airfield management for increased general aviation activity.
- RWY 1L/19R will close from Thursday, January 17, at 2200 (L) through Wednesday, January 23, at 1400 (L) for aircraft parking.
- The Fixed Base Operators (FBOs) anticipate between 300-600 general aviation (GA) aircraft arrivals. This is compared to over 700 arrivals in 2009.
- Designated parking areas have been assigned to each FBO.
- The majority of GA aircraft will arrive between Friday and Sunday, with most departures expected by Wednesday, January 23.
- The western portion of Apron W will close for aircraft parking. If there is no snow forecasted for the inaugural period, all of Apron W may be used for aircraft parking.
- Message boards will be placed at various locations on the field to assist the pilots, as well as published entry/departure instructions for the parking areas.
- Minimal changes are expected to the commercial flight schedule.
