Permanent AOA Registration

Registration stickers for carriers and U.S. Government vehicles are issued for a period of two years, commencing January 1st and expiring December 31st.

Temporary AOA Registration

Registration stickers for fuel trucks, contractors, vendors, and construction vehicles are valid for a period of one year or less. All companies requesting Temporary AOA Registration must also submit the Vehicle Permit Sponsorship form.

VEHICLE INSPECTION CHECKLIST

1) VEHICLE ID / MARKINGS

Vehicle must have Vehicle Identifier, sequential non-repeating number, painted/decals/magnetic sign on both sides (8 inches) and roof (12 inches).

2) AOA VEHICLE LIGHTING

Vehicle must have a 4 inch high & 2.5 inch diameter steady (Non-Movement) or flashing (Movement) amber light.

3) HEADLIGHTS

High beams and low beams must illuminate evenly when activated.

4) TURN SIGNALS

All turn signals must illuminate/flash and be visible from 20 feet away.

5) EMERGENCY FLASHERS

All emergency flashers must illuminate/flash and be visible from 20 feet away

6) HORN

Horn must be functional and heard from 20 feet away.

7) WINDSHIELD WIPERS

Windshield wipers must be functional and in good condition.

8) PARKING BRAKE

Vehicle must not move parking brake is applied.

9) BACKUP LIGHT AND/OR HORN

Must illuminate / sound when vehicle placed in reverse.

10) FIRE EXTINGUISHER

Must have properly charged and functional 5 lb A:B:C or B:C. Fuelers require 20 lb B:C

11) TIRE TREAD

Minimum of 1/8 inch tread in each third of the tire. No wire/steel contacting road surface & no cracking in sidewalls
